2001 COUNCILOR'S REPORT

Barbara L. Lences, Councilor

San Diego, CA –April, 2001

Attila Pavlath promised the council to end the council meetings on time during his tenure as President, and he did in San Diego with several minutes to spare. The council voted unanimously to increase 2002 membership dues to \$112 per annum (an increase of \$4). Council also approved a proposal to change the ACS by-laws to enlarge the membership of standing council committees. The goal is to increase council participation in governance. The proposal is subject to review by the Board of Directors. Two candidates were selected by council, from a field of four, as nominees for ACS 2002 President-elect. The successful candidates are Elsa Reichmanis of Bell Labs, Lucent Technologies and Bill Carroll, Jr. of Occidental Chemical Corp. It is noteworthy that both candidates are from industry.

At the request of Attila Pavlath, the Board appropriated \$300,000 for 2001/2001 to be used as stopgaps funding for those local sections and divisions that are struggling financially. A presidential task force was appointed by the Board to determine the distribution of the monies.

The committee on meetings and expositions reported that LCD projectors would be available in every room by the Spring 2002 ACS National Meeting (Orlando, FL). This is good news for presenters and program chairs alike, since this technology has all but replaced slides and overheads. The committee also emphasized that the recording or broadcasting, transmission or reproduction of any presentation, oral or poster, is strictly forbidden without the written permission of the division chair (this includes photographs). So, if you plan to webcast at a National Meeting, make certain you get your division chair's approval in writing.

The committee on constitution and bylaws reported that all local section by-laws are now electronically available from the ACS. If you're curious, it's now yours for the asking.

San Diego attracted 17,824 attendees (3rd largest) and 252 exhibitors with 472 booths (2nd largest). The 2001 membership campaign came to an end at San Diego with a Y2K total membership of 163,016 and a 94% retention rate. That's definitely a successful campaign.

Chicago, IL – August, 2001

Attila Pavlath gave everybody a scare by spending the night before the council meeting in the emergency room, but he ran the meeting with his usual fervor and kept his promise to end on time. Our President has been busy forming task forces, five to be exact, to address topics as

diverse as by-law changes, interim funding, ethics, electronic survey of members, and long-term finances of local sections and divisions. The goal being service to the membership (that's you) on a more personalized level. In this, Attila and Nina McClelland, Chair of the Board of Directors are in concert. Nina reported that the Board's focus is on people and partnerships and she encourages all councilors to attend the open session of the Board meeting where it is intended a special time will be set aside to listen to input/concerns from the councilors. This actually means, if you tell me your concerns/interests, your message is guaranteed to get before the Board of Directors. This is a strong incentive for you to speak up.

Halley Merrell, ACS Secretary was honored by a standing ovation of the council for all he has done for the Society (Halley announced his retirement). John Crum, ACS Executive Director mentioned in his report that the development of Green Chemistry was vital to the chemical enterprise.

The local section activities committee announced the 2002 National Chemistry Week (NCW) theme will be "Chemistry keeps us clean" and most importantly the '02 NCW celebration has been moved to the fourth week in October. FYI, the 2001 NCW theme is "Celebrating chemistry and art" and will be held the second week in November. The committee on meetings and expositions reported an increase in the 2002 registration fee to \$265 (a \$10 increase). Chicago attracted 15,290 attendees and 328 companies participating in the Exhibition.

Michael E. Condon – Chair-Elect

Michael E. Condon received his B.S. in Chemistry from Providence College in 1966, and his Ph.D. in Organic Chemistry from Yale University in 1970. He has been in the Princeton area since 1972, and has been employed by Squibb Institute for Medical Research, FMC Corp. and American Cyanamid Agricultural Research Division, where he was Assistant Vice President of Chemical Discovery. Dr. Condon has consulted for two start-up biotechnology companies in New Jersey and served as the Acting Director of the Patents & Licensing Office at the UMDNJ in 2000. He is a Patent Agent registered to practice before the United States Patent and Trademark Office. He is a member of the New Jersey Intellectual Property Law Association and the American Chemical Society.

Istvan Pelczer – Secretary/Treasurer

Istvan Pelczer received his Ph.D. summa cum laude in Chemistry in 1989 from Jozsef Attila University, Szeged, Hungary. His research interests include multidimensional NMR spectroscopy in combination with molecular modeling, applications to structural and dynamical studies of complex systems, and development and optimization of novel experimental methods, data processing and analysis in NMR. Dr. Pelczer is on the staff at Princeton University, where he has been a Lecturer and Senior NMR Spectroscopist since 1996.

Barbara L. Lences - Councilor

Barbara L. Lences is a Sr. Patent Agent for American Home Products Corporation. She has served as Chair and Alternate Councilor of Princeton ACS, and is currently serving as Councilor. She is also Treasurer of Chemistry & the Law Division of the ACS, member of ACS joint Board-Council Committee on Patents & Related Matters and advocate for Princeton ACS Local Section and its members.

Sharon received a B.
